**APPLICATION DEADLINE: Postmarked by September 5, 2011**

The Korean American Bar Association of San Diego (KABA-SD) will award one \$1000.00 scholarship to an eligible individual to take the California State Bar examination in February 2012 or July 2012. The scholarship amount will assist in covering the cost of the Bar Exam. You need not be of Korean ethnicity to apply.

**Eligible individuals must:**

- (1) Meet the requirements for taking and will be taking the California State Bar exam given in February 2012 or July 2012; and
- (2) Currently attend or have graduated from any accredited law school in San Diego County.
- (3) Be a paid member of KABA-SD (applicant may join KABA-SD at the same time as applying for this scholarship)

**Selection factors include but are not limited to the following criteria:**

- (1) Academic achievement, work experience, activities, and post law school goals;
- (2) Demonstrated leadership and a commitment to community service, particularly to the Korean and Korean American community and other diverse communities;
- (3) Financial need.

The scholarship recipient will be honored at the 2011 KABA-SD Annual Dinner. The scholarship recipient **MUST** attend the Thursday, September 15, 2011 Annual Dinner to receive the scholarship. The winner will not need to pay for the dinner.

The scholarship recipient will be selected and notified by the KABA-SD Scholarship Committee.
